PRESENTATION

Regal Commons (former South Regal Lumber Site)

- Developer Cyrus Vaughn, real estate broker Guy Byrd, developr's representative
 Dwight Hume, and architect Sam Nystrom
- Planning Commission recommended that County Business zoning, moving forward to the city council hearings for land use zoning determination and annexation.
- Presented tentative plans, some flexibility depending on final tenants
- Natural grocer will be anchor tenant who is requiring large amount of parking
- Smaller retail tenants
- Potential office building as place-holder on back of lot
- Two front corners to be developed with drive-through
- Signal light at Regal & 53rd Avenue with crosswalks

Comments:

- Sidewalks up against the street would be blocked with snow in winter
- Increased traffic -- Emergency vehicles access limitation?
 - No traffic study has been completed at this time, will occur before permits
- Are you building the entire project at once?
 - Not doing anything until grocery store is built, then one of the front sites, some pads will be left vacant, infrastructure will be in place at beginning. This will be a
- Where is the rock going from the site?
 - Use about half on site, sell the rest
- MUV Fitness takes up all the parking, how are you going to control parking?
 - There is more than adequate parking; Cyrus: we cannot provide free parking for MUV, we will put a warning note on the cars and then have them towed.
- What are you going to do with storm water?
 - Todd Whipple looking at storm water solutions
- What is the main entrance?
 - o Regal with secondary access on 53rd and 55th

- Pedestrian connections, there is no access along the east side where the Fisk alignment is.
 - We will follow the code with sidewalks and walkways all through the site. The retaining wall will be tall and then go down to zero
- Stoplight at 53rd, now 53rd doesn't go very far to the west.
 - Dwight Hume: city is requiring the signal light; no extension of 53rd
- Reality is that 55th Avenue is a major traffic conductor, why isn't the traffic light there?
 - Your comments will be addressed at the traffic scoping meeting
- South edge of your development (55th Avenue) is where your development should work to make it easy for pedestrians to come to your shopping area.
- We need a community bus for people to move between this shopping area and Lincoln Heights, would be a positive feature.
- Are developments like yours going to continue to go forth without any intent to make Regal a four-lane street? It's short-sited of the city to not extend to four lanes.
- What is the process with the city regarding concerns voiced here?
 - Property was purchased while in county with favorable zoning to owner; now having to switch in mid-project. Need Community Business zone to be favorable to owner and attract businesses. Feel that CC2 District Center is a "down" zone. 57th District Center hasn't been completed yet and it's too early and it gets in the way for us and the quality of tenants that we need.
- Will traffic study include apartments as well as project?
 - Yes.
- Studies have shown that building a four-lane road will just fill up and not alleviate the traffic.
- Hearing coming up, we need several neighbors to attend the city council meetings to provide testimony to provide the maximum benefit for the neighbors.

- Collective group of neighborhoods, meet monthly to increase neighborhood involvement.

- ACTION ITEM: Use of federal CDGB money to repair sidewalks in all neighborhoods if not in 11 of 28 neighborhoods that require repair for people in low income areas. Traditionally, Spokane has used some CDGB funds for sidewalk repair. Currently, a property owner who is low-income that doesn't fall within a certain block group wouldn't qualify to repair sidewalk. Proposal doesn't take money away from other projects. Individuals would apply for sidewalk funds.
 - Move that we support the broader aspect of CDGB funding sidewalk repair all over the city based on income regardless of which neighborhood residing in for a two-year trial period.
 - Motion passed: 12 for; 1 against

- \$500 per neighborhood for improving communication such as mailing, temporary signs, equipment, etc. Neighborhoods submit application.
