 - Board must adopt a resolution to enhance articles of incorporation, will be available soon. Fee of \$20.

Land Use Committee Update – Kerry Brooks, Ted Teske

- Land Annexation at 53rd & Regal
 - City Council approved CC zone and annexation
 - Mayor needs to sign ordinance
 - Not known if there will be a developers agreement
 - City Council stated that they need to look at planning for future annexation, develop pre-existing plans.
 - Joint Planning was set up with county and city (Mike Allen had requested a revisit to financial repercussions re annexation.) Annexation benefit will be that the city will control the Urban Growth Area.
- Palouse Cross Walk

- o Should be completed by April 17
- Gas Station at 44th & Regal
 - Maverick Gas Stations based out of Salt Lake City in pre-development, no permits.
