Land Use Committee Update – Kerry Brooks/Ted Teske

- KXLY District Center Design Review
 - January 25, collaborative workshop at Design Review Board meeting where residents can comment on plans. 5:30 pm in City Council Briefing room.
 - Reviewed design submission.
 - SNC LUC will meet to review design and prepare comments
 - Development will be built in two phases
 - Questions and discussion:
 - How much of this will really be built since this is not a binding site plan? What will actually be built is based upon what is submitted to the permitting departments.
- Vaughn Property on Regal
 - City developed a new designation for traffic impact "fast casual restaurant" (versus "fast food restaurant") for the two drive-thrus on property.

New Business

- SNC By-Laws Beginning Conversation Paul Kropp
 - Gonzaga Law Clinic has provided a revision, need to obtain consent of members regarding "2017 Preface" statement (attached).
 - o Paul will continue to meet with GU student
 - Jerry Boyd will also assist in review of by-laws.
 - Questions and Discussions:
 - If the city limits change, do the boundaries of SNC go along with it? Does the city council need to adopt new boundaries for SNC? Melissa Wittstruck from ONS will review ordinance.
 - Should the 501c3 by-laws portray SNC as only a neighborhood council or expand our activities beyond just a neighborhood council? For example; neighborhood councils participate in an advisory capacity to the city government. Could expand activities to include education, community policing, community events.
 - Need to determine how the three entities (city neighborhood council, state non-profit, federal 501(c)3 organization) will be addressed in revised bylaws.
