- Property behind abandoned radio station, Zoning change from Singlefamily Residential to High-density Residential. - First procedural step required at the beginning of comprehensive plan amendment process. No information about how many units. Surrounded by apartments. Maximum density allowed 15-30 units/acre.
- Q: When would the general public know the fine details on this property.
  A: Not until a developer buys the property.
- Comment: Zone amendment could be extended to adjacent property as well since the city tries to avoid pocket zoning.
- Q: Does this property if developed for apartments eligible for tax exemption. A: Not at this time under current regulations.
- Comment: It is early in the process, fill out comment cards and SNC will send to the Planning Department. SNC will follow the process and keep members notified. When it's time for city council to hear the amendment, please show up at the hearing and testify.

## Community Assembly Meeting Report – January 2, 2020

22 neighborhoods present

NDCP workshops coming Jan 13, 14, 15 – (Andy will attend ono Jan 13) Brean Beggs: They will fill the CC position by narrowing 32 applications to 6 or 7 and interviewing them on Jan 13. Mayor wants to get along with the CC. More downtown police presence coming including a new precinct office and more cars, beat cops. There will be a larger homeless shelter next year – there is better coordination with City of the Valley and County re homelessness. Refinement and expansion of the Community Court system coming to reduce jail time. CC hiring three new researchers for them – Cara Odegard and Melissa Morrison are two.

Dean Gunderson gave a brief review of the Design Review Board and its function. DRB is getting clarification on its activities/duties/responsibilities for "other" projects outside the normal ones.

CA committees are working on their goals.

There is an extra \$25,000 for leadership training for Neighborhood Councils, and all boards and commissions – joint effort with Gonzaga – there will also be matching money...details to follow.

There will be a workshop on traffic calming on Jan 13 from 6-7 in the CC Briefing Center.

The Engagement Grant Training will be February 10 at the West Central CC. There will be a workshop on Clean-Up in the CC Briefing Center on February 27 from 6-7.
