# Officer Prim - SPD - Neighborhood Resource Officer

- ❖ Target is a hot spot.

# **Community Assembly Report – Kris - October Draft Minutes Attached**

- ❖ The Spokane Parks Foundation is receiving grant requests for up to \$6,000 for things that augment physical equipment and programs of parks.
- ❖ The city budget will be finalized by the mayor on 10/27 and public testimony will be taken November 3 10.
  - ➤ The city needs to replace the 911 system which has a cost estimate of \$20 million.
- ❖ ONS is auditing the neighborhoods for baseline activity and growth.
- ❖ Dump passes end 10/31. Rita has them.
- Crime is down citywide.
- Garrett Jones, park's director, spoke about the parks and schools ballot initiative.
- Santiago Rodriquez-Anderson is the new liaison to the Climate Resiliency and Sustainability Board.
- Urban Forestry will be planting trees. This summer they removed 350 of 400 dead trees.
  - ➤ There is an opening on the committee for a commercial representative. See Kris for more information.

- ➤ 50 trees are available free to businesses downtown and an arborist service will be available to advise on keeping the trees alive.
- ❖ 30 spots are left for the Neighborhood Summitt on 10/25.
- ❖ Nominate good neighbors for a CA award to be given 12/13.

# **Transportation Committee - Paul**

- ❖ The Transportation Committee meeting is next week and our request to move the hawk light on 37<sup>th</sup> is on the agenda. They will rank projects for funding, but the city council has not decided on the amount of funds.
- ❖ The city is building a roundabout at Palouse and Freya. It is a peanut shape, accommodating 6 entrances. It is funded and will be constructed next year. Perhaps Southgate asks a city representative to present to use?
  - Q: The roundabout on the north side by Costco has art in the middle. Is it possible to have art in a city roundabout?
    - A: ONS partners with Spokane Arts, a 501c3 so maybe.
      Southgate could ask ONS.

# Land Use Committee - Paul

- ❖ The city and the county are updating their comprehensive plans. The county will substantially revise its plan, and Southgate has the county on 2 sides.
  - ➤ There is a public input workshop on 10/21 at Moran Prairie Library, 5:30 -7.
  - > 57<sup>th</sup> is a designated center on the city plan but the county is suggesting a busier plan.
  - ➤ Glenrose is in the urban growth area, and the county may try to designate it as developable.
  - ➤ The plan must be completed in 2026 so maybe we should invite the county to a Southgate meeting.

- The city comprehensive plan update workshop is at Ferris HS on 11/5, 5-6:30.
- ❖ Youth Sports just announced it is not developing a complex at 37<sup>th</sup> and Glenrose.
- ❖ On 10/22 at 4 pm in Council Chambers at City Hall, the Planning Commission will be discussing the City Capital Improvement Plan.

## Other Business

We need a new webmaster. Kris will train.

# CA Meeting Notes - October 2, 2025 - taken by Andy Hoye

COPS NW is doing a fundraising – spokanecops.org. City has not reached an agreement with them.

Parks Foundation (spokaneparksfoundation.org) is open for grants – up to \$6,000.

City of Spokane Budget timeline: October 27, receive budget from Mayor / November 3 = public testimony / November 10 – second hearing / Nov 17 or Nov 24 – adopt budget.

City is still struggling to replace the SREC 911 system. The cost will be around \$20M per year for five years!

ONS is auditing the Neighborhoods for a baseline measure of activity and growth. Mobile feedback trailers are working hard – data to be released in November. Disposal passes end October 31. Crime is down, citywide.

SRTC is a Federally mandated agency that does long-range planning. Fatal and Serious Accidents are rising. The Metropolitan Transportation Plan / Horizon 2050 is in the works. Priorities are 1) Preservation, Maintenance and Operations, 2) Improve Safety and Security, 3) Support Systems Management and Operations, 4) Cost Effective Transportation Solutions, 5) Invest in Public Transit, 6) Multi-modal Options, 7) Regional leadership.

Garrett Jones (Parks Director) spoke: togetherspokane.org is the website for reviewing the ballot initiatives for parks and schools. There is matching funding from the State. Parks maintenance staff will increase by 50%.

Santiago Rodriquez-Anderson was approved as the CA Liaison to the Climate Resiliency and sustainability Board.

The CA/CC workgroup discussed the City Budget. Some CC members are unhappy with the meetings and there were questions as to the need for this group if the former quarterly CA/CC meetings resumed.

The Urban Forestry Department is planting trees with the Tree Equity Grant – need trees downtown and need partnership with business owners there. email contact is urbanforestry@spokanecity.org
