



Presidents' Day Notifications (Monday, Feb. 16)

- **On-street parking meters and kiosks** will not require payment on Monday, Feb. 16, because of the Presidents' Day holiday. However, please remember all parking rules, including time limits, still apply.
- **The Spokane City Council** agenda review and legislative meetings have been canceled for Monday, Feb. 16.
- **Spokane Public Library** branches will be closed on Presidents' Day.
- **Spokane City Hall will be open** including Spokane 311 and the Development Services Center.
- **Garbage and recycling** pickup will be on its normal schedule.
- **Spokane Municipal Court and Community Justice Services** will be available by phone only.

2026 Spokane Safe Streets for All/ Traffic Calming Updates:

- To streamline public feedback for the 2026 traffic calming program, City staff are accepting neighborhood council and resident feedback primarily via the City's 3-1-1 Customer Service channels.
 - Beginning Feb. 2, 2026, the City's 3-1-1 team will be collecting traffic calming concerns and feedback. Residents and Neighborhood Councils (NCs) should submit comments by:
 - Calling 3-1-1
 - OR by visiting the City's Customer Service Request webpage at <https://tinyurl.com/SpokaneServiceRequest> and submitting an online request **[Recommended method for uploading documents, photos, resolutions from NCs, etc.]**
- Concerns submitted via call or online request between Feb. 2, 2026 – March 31, 2026, will receive consideration for this upcoming funding cycle (note: consideration does not mean it will be funded.) The 3-1-1 service staff and online portal will remain open after March 31 for ongoing collection of concerns.
- In addition to submitting comments about potential/new traffic calming projects, NCs and residents are encouraged to review the 2023 DOWL Proposed Project List at <https://tinyurl.com/2023TrafficProjects>. These projects were developed after traffic calming workshops with neighborhood councils in 2023. Note: some of the projects in the document have been completed.
